# 2025-2026 Tuition and Fees

## **Registration Fee**

This fee is due when registration forms are completed. Registration Fee is non-refundable and must be paid through FACTS.

## **Operational Fee**

This fee includes HSA fee along with textbooks fee, school yearbook, technology and other school operating expenses.

## **Home and School Association Dues**

The funds are used for HSA events and student needs throughout the school year. Funds will be used for Winterfest and other activities.

## **8th Grade Fee**

This fee is in full due by January 1, 2026 and is used for 8th grade end of year activities, trip cost, bus cost and graduation fees. 8th grade fee is non-refundable and must be paid through FACTS. This fee can be split into payments beginning in August-December 2025.

## **Volunteer Hours KG through Eighth Grade**

Each family is required to complete 20 hours of volunteer hours. Hours should be completed between August 2025 and May 1, 2026. It is the responsibility of each family to log hours served by signing in and out in the school office. If you have not completed your required hours a \$300 fee will be collected on May 1, 2026 through FACTS.



# 2025-2026 Tuition and Fees

## **Enrollment Guidelines**

- Families with accounts in arrears for the current school year may not re-enroll for the next school year until all accounts are made current. This includes but is not limited to tuition, after school care, outstanding fees, etc.
- Enrollment is only complete and a student's space is only reserved by completing the required online enrollment process and paying the Registration Fee.

## **Financial Policies**

- Resurrection Catholic School is responsible for all operating expenses. Our school's financial stability depends on the prompt and faithful payment of tuition. We will make every effort to assist families when needed, however, when an account becomes two (2) or more months in arrears, Resurrection Catholic School may choose to dis-enroll the student(s). In the event the outstanding balance is not paid in full, the family will be responsible for the balance due and any legal fees that may be incurred seeking restitution.

## **FACTS Tuition Management Service**

- Families are automatically placed into the FACTS payment plan previously selected during the 2024-2025 school year
  - a. Families do not create a new account, even if adding a new student.
- b. The plan options include paying over 10 months or a one-time payment, all deducted via FACTS. Payment plans must conclude in May of 2026.
- There is an annual, non-refundable FACTS administrative fee paid to FACTS for tuition enrollment per family. The fee varies based on your payment plan. This fee will be added to your tuition collected by FACTS.

## **Withdrawal Policy**

- Families must notify the school in writing if a student is to withdraw from the school.
  - a. All fees are non-refundable.
  - b. Families are responsible to pay the tuition through the date of attendance. If the school year has not begun, no tuition will be due.
  - c. The school will not forward records for students who withdraw with an outstanding balance.

\*\*\*Drop in care/unexpected services: For parents needing OCCASIONAL after school care services, the BASE program offers Unexpected Services. The unexpected service rate is \$15 per child, per day. This service may be used a MAXIMUM of two (2) times per week. Any charges incurred will be added to your monthly FACTS account.
